PUEBLO OF JEMEZ HOUSING AUTHORITY RECEIVES \$5 MILLION GRANT FROM HUD

The Pueblo of Jemez Housing Authority (POJHA), a Tribally Designated Housing Entity (TDHE) for the Pueblo of Jemez, is pleased to announce they have been awarded \$5,000,000 from the U.S. Department of Housing and Urban Development's FY2020 Competitive Indian Housing Block Grant (IHBG).

This much-needed funding will be used over the next several years to complete a portion of Phase I of the Pueblo Place Subdivision and build lease purchase homes for community members to address the severe lack of affordable housing within the Pueblo of Jemez.

"We are truly thankful for this award and HUDs' support within our tribal communities," says Greta Armijo, POJHA Executive Director. She is responsible for overseeing the daily operations of the authority and will lead the subdivision project. "Lack of housing in our Tribal Communities has been an issue for a long time, and this was more evident during this pandemic. This new funding will allow the Pueblo of Jemez to build much-needed homes to ensure that our families have a safe place to live," says Pueblo of Jemez Governor Michael Toledo, Jr.

About the Pueblo of Jemez Housing Authority

The Pueblo of Jemez Housing Authority was established in December 2019 by the Pueblo of Jemez Tribal Council pursuant to the Native American Housing Assistance and Self-Determination Act of 1996 and is governed by a five-member board, all from the Pueblo of Jemez. They are dedicated to addressing the housing needs of our community members.

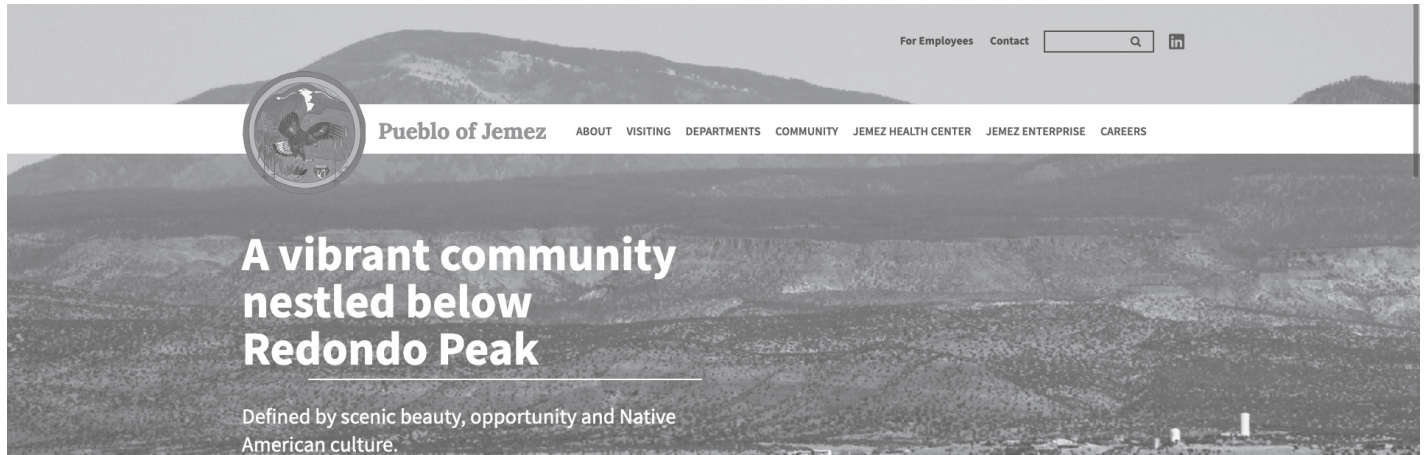

The Pueblo of Jemez (POJ) Administration has launched a new user-friendly website for online access to essential data and services offered by the Pueblo's Departments and the Programs. The new site permits user access to forms, applications, and current information.

The site also features visitors' information, access to current and past Walatowan newsletters, events, local enterprises, and spotlights for crucial communications and featured events.

The website is live and can be used to search and apply for employment within the POJ Departments. The Information Technology Department updates the site as needed to ensure users are receiving the most up-to-date information. Anyone who visits the Pueblo of Jemez website can explore news, events, history, and information about its' Tribal Government and Leadership.

When developing the new website, the POJ website developers kept several goals in mind:

- Represent the Walatowa Community and Departments with great respect.
- Brand and showcase the Pueblo of Jemez, highlighting its qualities, including why it is a great place to work, visit and do business.
- Serve the needs of all users by letting them easily find information that will allow them to access critical services, share information and interact with staff.
- Provide a pleasant experience to all users by making it easy to complete their tasks or find what they want straightforwardly.
- Focus on making content that is useful, interactive, and engaging.
- Allow for migrating and updating content and training our web editors to contribute to and maintain the website.
- Provide information to outside entities, partners, and anyone interested in learning about the Pueblo of Jemez.
- Allow users easy access to pertinent information.

Discussion of the project began in the late summer of 2019. A significant amount of time was spent on the process of gathering, vetting, and editing information to meet the tribe's procurement processes. The challenges of the COVID-19 pandemic set back the tribe's initial launch date. However, that did not stop the overall goal. The process was officially completed in Spring of 2020, and the new website is actively running. Community members interested in any further information or questions can call the Pueblo of Jemez IT department to provide general guidance. However, it is best to contact each department for anticipated data not located on the website. The front desk is very resourceful in routing calls or providing contact information for each department.

Pueblo of Jemez New Phase 3 Lockdown

Jemez Pueblo continues to have zero active COVID-19 cases and zero households in quarantine. The Pueblo of Jemez Governors have decided to move into Phase 3 of the Community Lockdown until July 31, 2021. Phase 3 Community Lockdown is detailed below.

Phase 3 Lockdown: Effective Monday, June 1, 2021, essential days for fully immunized individuals ONLY will be Sunday - Saturday (7 days/week). Essential days for partial/non-vaccinated individuals will be Monday - Wednesday:

The following Revised guidance is to be followed:

- Lockdown on Thursday, Friday, Saturday, and Sunday will be very strict for partially/non-vaccinated individuals, and the only exceptions will be by permission granted in advance by Governors.
- Each person must show proof of vaccination status (card) of full immunization. Failure to do so will eliminate permissible access. Partially/non-vaccinated children will be allowed access ONLY on Monday, Tuesday, Wednesday.
- Checkpoints will be checking dates for each person.
- If you have lost your vaccination card and you received your COVID-19 vaccine at the Jemez Comprehensive Health Center, you may call 575-834-7413 to request a certificate/proof of vaccination.
- Out-of-state travel: Out-of-state travel will be allowed in Phase 3 community lockdown. Below are quarantine guidelines for Pueblo of Jemez employees and all tribal/community members to follow:
- Fully immunized individuals will NOT be ordered to quarantine upon return from travel out-of-state but will be required to test 5 days after returning from travel. Pueblo of Jemez employees will be mandated to self-report travel to the JHHS Response Team to receive further guidance. All tribal community members are encouraged to self-report travel to the JHHS Response Team to receive further guidance.
- Partially/non-vaccinated individuals will be ordered to quarantine upon return from travel for seven days and will be required to test 5 days after returning from travel. All Pueblo of Jemez employees will be mandated to self-report travel to the JHHS Response Team to receive further guidance. All tribal/community members are encouraged to self-report travel to the JHHS Response Team to receive further guidance.
- Non-resident Tribal members: Non-residents will not be allowed in the Pueblo unless an approved pass is obtained from the Governor's office. Having a vaccination card does not grant "permissible" access into the Pueblo for non-residents members.
- Friends of family, boyfriends, or girlfriends who are not Jemez tribal members will not be allowed to visit or reside. Such persons will be removed by order of the Governors.
- ALL vehicles will be required to stop at each checkpoint to state the person's case even if the worker is busy. Each checkpoint worker is also required to stop each vehicle to hear each person's case.
- You will be turned around and not allowed to leave the Pueblo if your travel is determined to be unnecessary/non-essential.
- Checkpoint passes for partially/non-vaccinated individuals will be required for non-essential days and will be approved/disapproved by the Governors on a case by case basis. Passes can be requested at 575-834-7359.
- If you are an essential employee who is partially/nonvaccinated, working for the Pueblo of Jemez, or outside,

we request a signed letter from your employer to show at the checkpoint. Bring your work ID.

- Wood hauling/hunting will be allowed on your designated essential day and weekend with proof of permit.
- Trash hauling through Green Acres Road will cease after June 1st. All trash hauling will then be allowed through the checkpoints based on allowed essential days.
- Entry/exit for farming, ranching, or related activities will be allowed. If gas/diesel is needed, proof of gas can or vehicle low fuel status must be provided.
- As athletes continue for high school and summer leagues, players will be allowed to participate if proof of registration or schedule is provided.
- Parking at road closures or barricade areas is now allowed. Citations or boots on vehicles will be assessed for such actions.
- Funerals - The process and guidance for funerals remain unchanged until the Death/Funeral guidance is further amended.
- Local Food Sales - Food sales by community members are currently prohibited; however, there are now being considered by the Governors and could be allowed in the near future.
- The new curfew is 9:00 PM - 5:00 AM, seven days a week. Be at home within this time period.
- **Vaccination status:** Based on the fully immunized percentage of enrolled tribal members.

The Jemez COVID-19 Response Team is working diligently to vaccinate the community and to fight the spread of the COVID-19 pandemic. For tribally enrolled members, 16 years or older, we are in the Yellow status.

Considering that the Pueblo of Jemez community has moved into the yellow status and with zero (0) active COVID-19 cases, this has prompted Leadership to move into Phase 3 of the Community Lockdown. JHHS has also begun vaccinating 12-to 15-year-olds tribal enrolled members/community members. If you or your child age 12 or older and are interested in receiving the COVID-19 vaccine, please call 575-834-7207 to schedule your appointment.

Tribal leadership asks for the community's support and asks individuals to consider receiving a vaccine as it will help maintain the impact of COVID-19 in the Jemez community. The Jemez Health and Human services team is doing its best to gather data on vaccination status for community members residing in Jemez. If you have received a COVID-19 vaccination at another site, please contact JHHS at 575-834-7413, so we can update your records.

Conditions: By authority of the Governors, the below-listed requirements must be followed for the community to remain in Phase 3 Lockdown. Any broken condition listed below will reinforce Phase 2 Lockdown. Obeying said conditions will prompt Phase 4 of lockdown to be implemented.

Masks must always be worn! No one is exempt from not wearing a mask. Receiving a vaccination shot does not "earn" one the right to no longer wear a mask.

If the Pueblo of Jemez has five active COVID-19 cases or ten households in quarantine, the Pueblo of Jemez will immediately revert to Phase 2 Lockdown.

Excessive disrespect and disobedience of checkpoint workers by community members.

Community members who abuse set conditions and revised guidelines.

Surveillance Testing:

The Pueblo of Jemez has implemented surveillance testing for households in the Jemez community. Pueblo of Jemez intends to test at least 70% of households in the Pueblo monthly. In lessening restrictions for the Pueblo of Jemez, we ask for your support and cooperation when your household is randomly selected to be tested for COVID-19. The surveillance testing will allow for the pueblo of Jemez and JHHS to monitor COVID-19 activity within the Jemez community.

Please continued to do your part to protect and ensure the well-being of the Jemez community. With your support and following proactive measures as provided, together, we can reduce the impact of COVID-19 in our community. Please respect our Checkpoint Personnel for their dedication to keeping our community safe, and remember they have authority on behalf of the Governors. Community members violating lockdown rules are subject to fines of \$100 per violation.

Water Conservation Tips

2020/2021 winter has been the driest calendar year in many of New Mexico rainfall records. The Pueblo of Jemez Public Works Department is asking community members to reduce their water usage during the spring/summer months.



What can you do to conserve

- Stop leaks! Check your facets, toilets, irrigation and any other water using appliance for leaks.
- Run water only when using it- not while brushing your teeth or shaving. Keep showers short.
- Use a broom instead of a hose to clean your driveway, patio or other hardscape.
- Replace your washing machine with an Energy Star rated washer.
- Replace your old toilet with a water efficient low flow toilet.
- Water plants only when you need.
- The use of hoses with spring loaded shut-off nozzles for washing of vehicles, so long as only minimum amount of potable water is used.
- The use of potable water for livestock tanks are strictly prohibited. All ranchers are highly encouraged to utilize the fill up station on Owl Springs.

Planning, Development and Transportation Department Project Updates

The Planning Development and Transportation Department (PDTD) is working on numerous infrastructure improvement projects. Below are the project status updates. If you have questions or would like to schedule a meeting for more information, please contact Sheri Bozic, Director, at (505)382-3299.

NM-4 Multi-use Pedestrian Trail – Officially Named “Hemish Path to Wellness”

The Pueblo received a \$4.7 million grant award to design and construct a multi-use pedestrian trail along the NM-4. The project entails planning, designing, and constructing a paved pedestrian trail between the Pueblo Place Housing Subdivision and Bear Head Canyon Road. This project will provide safe pedestrian passage between many community service buildings and homes located along the NM-4. The engineers have completed the 60% design and are working on the 100% design. Construction is scheduled to begin in early 2022.

NM-4 Bypass

Tribal leadership and staff from the PDTD, Realty Department, Public Works Department, and Natural Resources Department are currently working with the NMDOT and their engineering firm to complete the planning and design for the project. After the procedure is completed, the Pueblo will seek funding to construct the NM-4 bypass.

NM-4 Traffic-Calming Project

The project will design and construct a gateway treatment sign along the NM-4 at each entrance to the Pueblo. The signs will be installed on the east side of the NM-4 at approximate milepost 2 and on the west side of the NM-4 at approximate milepost 8. The purpose of gateway treatment signs is to notify drivers that they are entering a community and promote safe driving and respectful behavior.

Emergency Modular Buildings

The project will design and construct seven emergency



modular buildings west of the Jemez Community Wellness Center to conduct COVID-19 testing, facilitate distance learning, and improve telework capabilities for employees during a public health emergency. The project will be completed in summer 2021.

Walatowa Early Childhood Learning Center

The PDTD is working closely with the Education and Public Works Departments to construct the new early childhood learning center. The project entails demolishing the existing head start building and constructing a new early childhood learning center. The project is expected to begin in fall 2021.

Childcare Center Expansion

The PDTD is working closely with the Education and Public Works Departments to design and construct an addition to the south side of the Childcare Center. The project entails the expansion of classroom, office, and storage space.

Road Maintenance

The road maintenance program staff works diligently to improve roadway and parking lot conditions throughout the Pueblo. The program has completed or is currently working on the following projects:

- Re-paving the asphalt entrances at the C-store
- Installing road signs and mile markers on the west side of the Pueblo
- Routine road maintenance
- Replacing damaged signs
- Installing new gates at Chamisa Rd. & Day School (at the intersections of the NM-4)

One Year Anniversary for the New XRAY room and equipment at Jemez Health Clinic



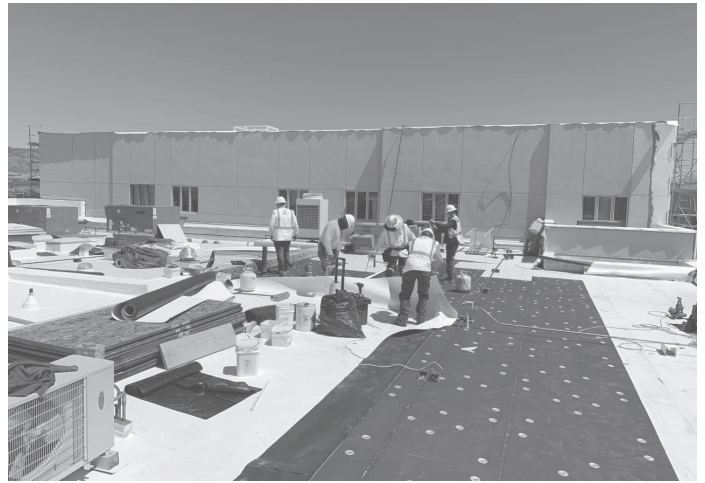

Jemez Health and Human Services Construction and Parking Updates

Construction Progress to Date:

The Jemez Health and Human Services Construction is halfway to completion. All construction work is proceeding on the west side of JHHS inside and outside. The west lot of the JHHS is still close to completion of construction.

Safety:

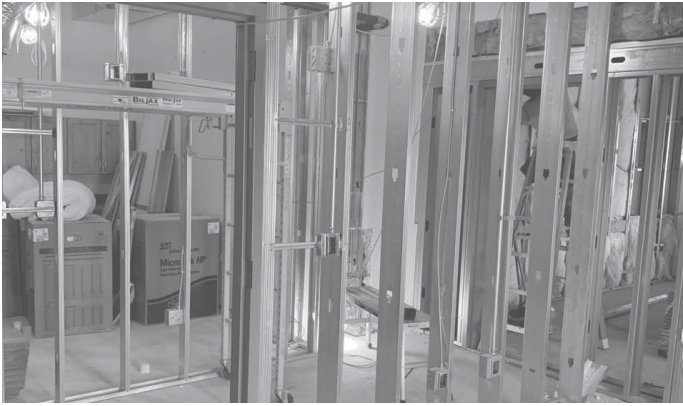

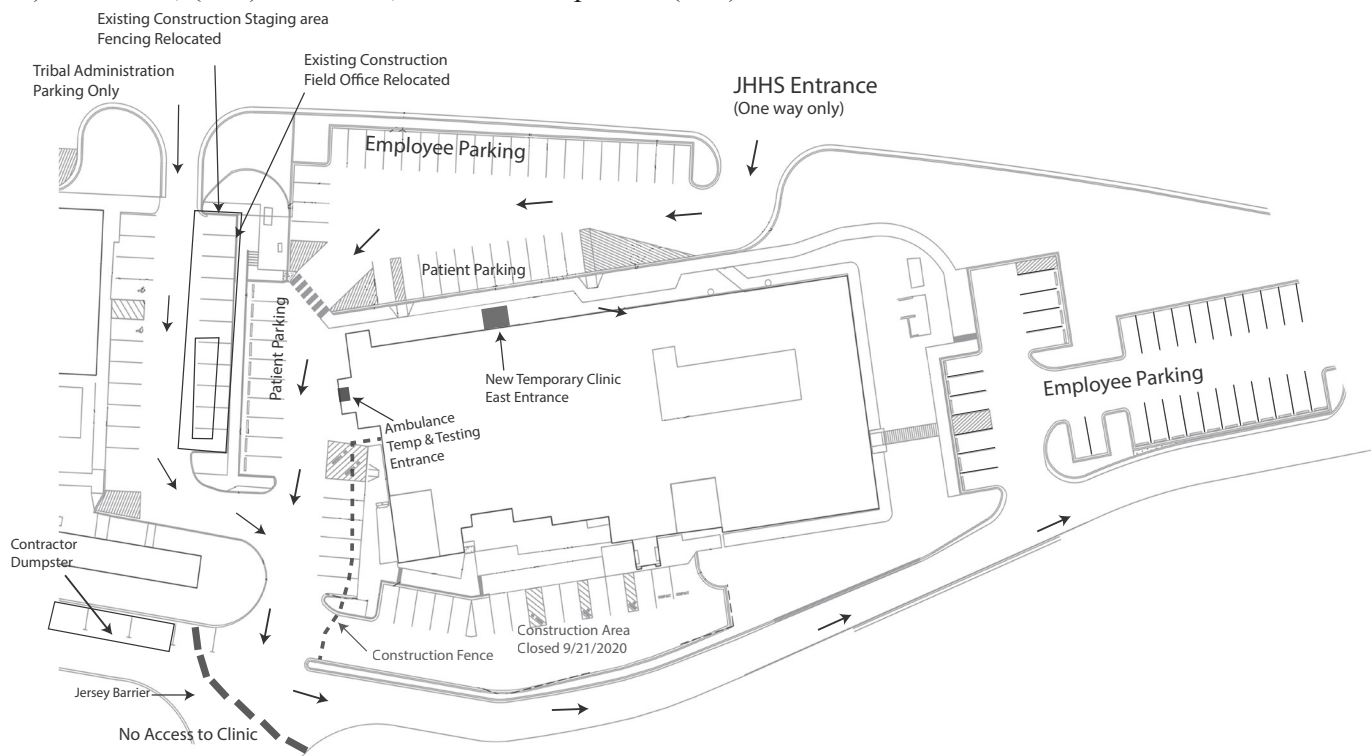


Parking:

Summer is just around the corner, and we at the JHHS Transportation Program are here to provide you with your non-emergent medical appointment transportation.

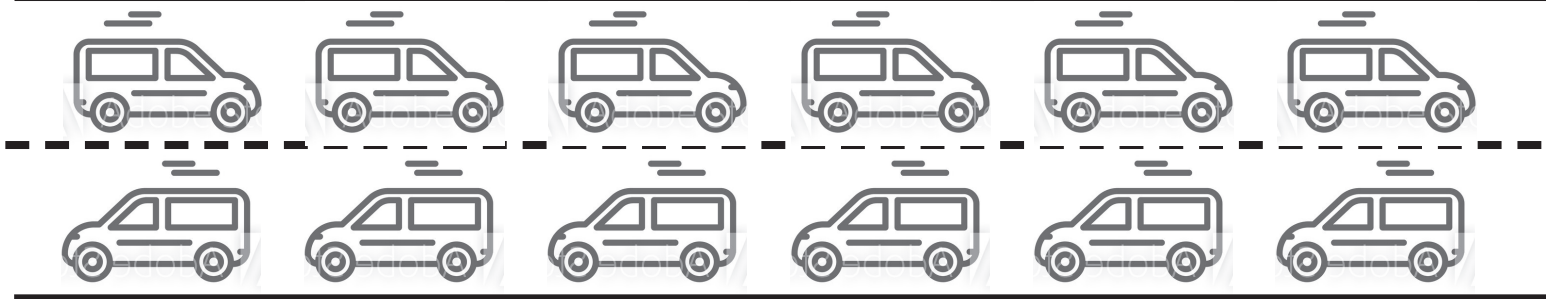
Our office hours are 8:00am – 12:00pm and 1:00pm – 5:00pm. However, one of our drivers is always on call during the lunch hour.

JEMEZ HEALTH SERVICES**How to recognize and treat headaches during these stressful days**

What are common reasons for headaches? There are many causes for headaches, anywhere from stress to hormone changes. They can be bothersome up to debilitating. Many headaches are more treatable if intervention starts early in the course. Sometimes if you are treating headaches too much, you can get rebound headaches. Two of the most common headaches are tension-type headaches and migraine headaches.

What are the symptoms of tension-type headaches? — Symptoms of tension-type headaches include:

- Pressure or tightness around both sides of the head or neck
- Mild to moderate pain that is steady and does not throb
- Pain gets worse by activity
- Pain can increase or decrease in severity throughout the headache
- There may be tenderness in the muscles of the head, neck, or shoulders

People with tension-type headaches often feel stress or tension before their headaches. Unlike migraines, tension headaches occur without other symptoms such as nausea, vomiting, sensitivity to lights and sounds, or an aura.

What are migraines? Vascular tone changes in the head cause—Migraine headaches. They cause moderate to severe pain that gets worse by light, noise, and motion. Some people also experience nausea and vomiting. Migraine headaches typically last for a few hours but may stay for as long as three days. When a person has a migraine, it usually is soothing to rest with the lights off in a quiet room. Women are affected more commonly than men and often have new onset of migraine during puberty or childbearing years. Some women note a change in their headaches around menopause. Some children are prone to migraines, and they may run into families.

What are the symptoms of migraines? — Symptoms can include:

- Headache – The headache gets worse over several hours and is usually throbbing. It often affects one side of the head.
- Nausea and sometimes vomiting
- Feeling sensitive to light and noise – Lying down in a quiet, dark room often helps.
- Aura – Some people have something called a migraine "aura." An aura is a symptom or feeling that happens before or during a migraine headache. Each person's aura is different, but in most cases, the aura affects the vision. You might see flashing lights, bright spots, or zig-zag lines or lose part of your vision. Or you might have numbness and tingling of the lips, lower face, and fingers of 1 hand. Some people hear sounds or have ringing in their ears as part of their aura. The aura usually lasts a few minutes to an hour and then goes away, but most often lasts 15 to 30 minutes. Women who get migraines with aura usually cannot take birth control pills. That's because they might increase the risk of stroke.

Is there anything I can do to prevent migraines? — Yes. Some people find that certain things trigger their migraines. You can find out if there is anything you should avoid eating or doing. You can also write down what medicine you took and whether or not it helped.

Common migraine triggers include:

- Stress
- Hormonal changes
- Skipping meals or not eating enough
- Changes in the weather
- Sleeping too much or too little
- Bright or flashing lights
- Drinking alcohol
- Certain drinks or foods, such as red wine, aged cheese, and hot dogs

How are headaches treated? — Many different medicines can help with headaches. Your doctor can help you find the best treatment for your situation.

For mild headaches, your doctor might suggest an over-the-counter medicine such as acetaminophen (sample

brand name: Tylenol), ibuprofen (sample brand names: Advil, Motrin), or naproxen (sample brand name: Aleve). There is also a medicine that combines acetaminophen, aspirin, and caffeine (sample brand name: Excedrin). For more severe headaches, there are prescription medicines that can help. Treatments including learning relaxation techniques and ways to manage stress are also beneficial.

Warning: Do not try to treat frequent headaches on your own with non-prescription pain medicines. Taking non-prescription pain medicines too often can cause more headaches, later called rebound headaches. If you have headaches that you have to treat more than ten days a month, you need to see your doctor for evaluation. You may need preventive therapy and possible preventative medication.

HEADACHE DANGER SIGNS — The vast majority of headaches are not life-threatening. However, headache can be a symptom of severe conditions affecting the brain, such as infection, inflammation, or bleeding within or around the brain. You should seek medical attention immediately if your headache:

- It comes on suddenly, becomes severe within a few seconds or minutes, or could be described as "the worst headache of your life."
- It is extreme and occurs with a fever or stiff neck.
- It happens with a seizure, personality changes, confusion, or passing out.
- Begins quickly after strenuous exercise or minor injury.
- It is new and occurs with weakness, numbness, or difficulty seeing. While migraine headaches can sometimes cause these symptoms, you should be evaluated urgently when these symptoms appear.

Headaches can make life miserable. With stress from the pandemic and lockdown, we are seeing more patients in the clinic for headaches. If you are suffering from headaches either acutely or chronically, there is help. Acute care clinic is for immediate treatment for severe headaches, while PCP appointments are for general care and prevention.

What We Should Know About Our MMIW

Missing and Murdered Indigenous Women (MMIW) is a grassroots movement that began with First Nations women and families in Canada and compelled the Canadian government to initiate a national inquiry.

Indigenous communities are experiencing alarming missing and murdered women, girls, and LGBTQ2S individuals throughout the United States and Canada.

MMIW – an acronym for Missing and Murdered Indigenous Women, is used to bring the thousands of missing person cases to the forefront. Most cases go primarily unnoticed outside tribal communities, and the justice system has been of little help to the victims and their loved ones. The red hand symbolizes the voices of these women being silenced.

May 5th was the National Day of Awareness for Missing and Murdered Native Women and Girls. Social distancing and “shelter-in-place” prevented in-person MMIW activities, but Native communities and programs were encouraged to participate in this year’s National Day of Awareness creatively. 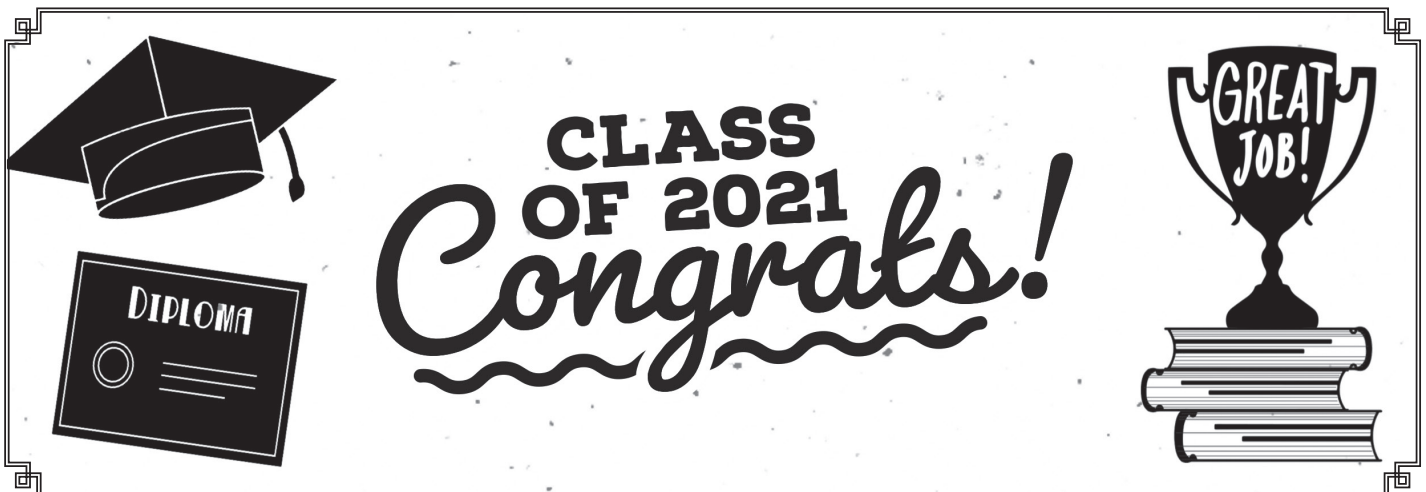
